This includes commissioned and warrant officers of the US Army, US Navy, US Marine Corps, US Air Force, US Coast Guard, US Public Health Service, and the National Oceanic and Atmospheric Administration.
- b. Scouting organizations (BSA and GSUSA) **not previously supported** by MOWW chapters.
 1. If you were not previously supported by a MOWW chapter, please email merchandise@moww.org (MOWW Store) and ask if there is a MOWW chapter local to your organization. If there is, you will be provided contact information to arrange for local MOWW chapter support.
 2. If there is no MOWW chapter in your local area, please email merchandise@moww.org and request support, providing the scout's full name, the award earned, the troop/council, and the date of the planned presentation. Please also provide your (the requestor's) full contact information (Point of Contact name, mailing address, phone and email). Please allow two weeks for delivery.

Whereas, The Military Order of World Wars encourages its local chapters to actively assist in the chartering of local JROTC/ROTC groups as Venturing Crews; and


