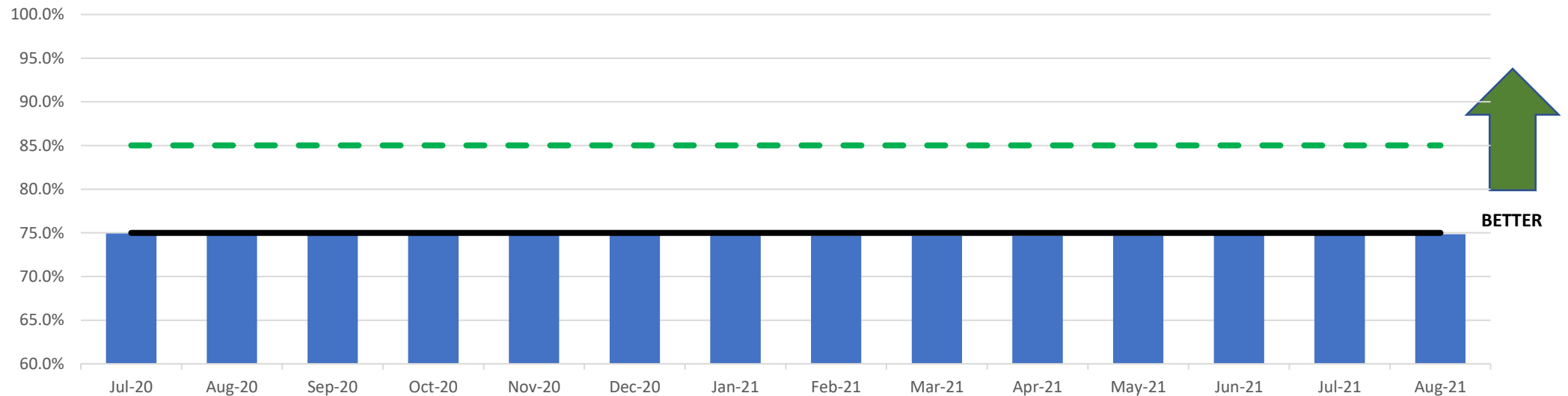




IRS Requirement #1: Past & Present Armed Forces Members

IRS Requirement #1: $\geq 75\%$ of MOWW Members must be past or present members of the US Armed Forces, i.e., USA, USMC, USN, USAF, USCG & USSF



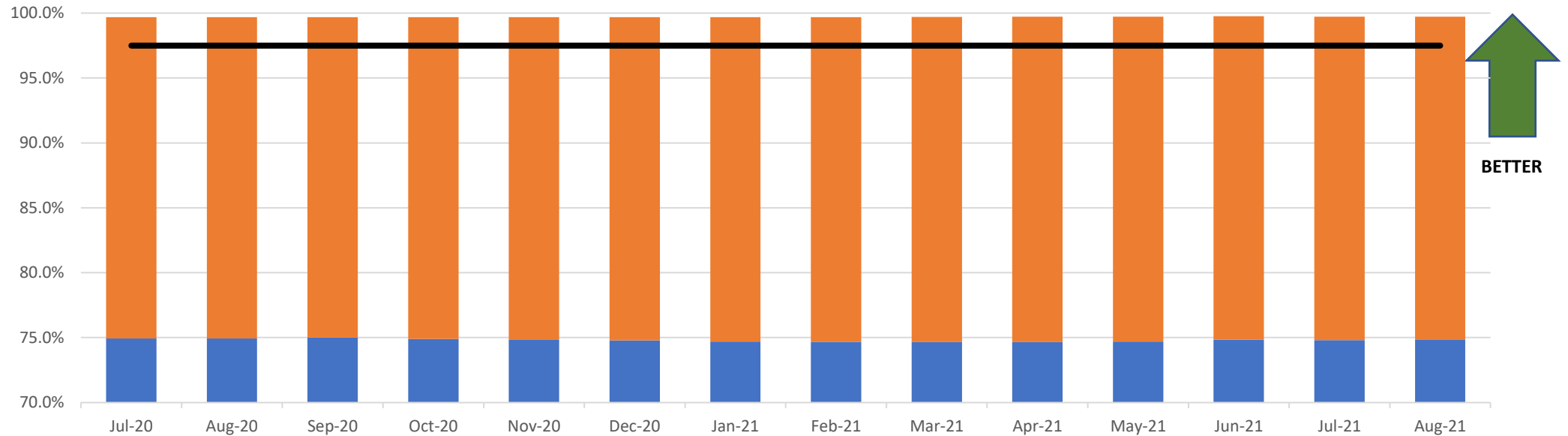

IRS Member Requirement #2: Past & Present Armed Forces, Cadets, Spouses & Descendants



IRS Requirement #2: $\geq 97.5\%$ of MOWW members must be present/former US Armed Forces members, cadets (college/university ROTC or Services academies), spouses, widows, widowers, ancestors or lineal descendants of present/former members of US Armed Forces



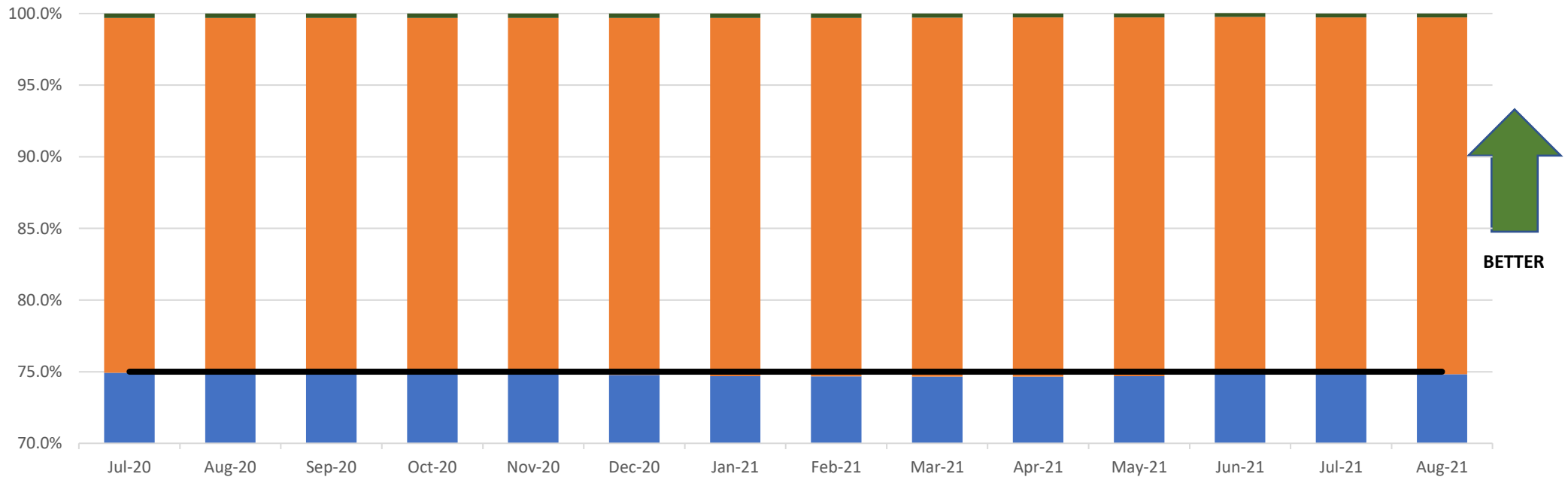

IRS Member Requirement #3: Past & Present Armed Forces, Cadets, Hereditary and USPHS & NOAA veterans



IRS Requirement #3: $\geq 75\%$ of MOWW members are veterans, spouses of veterans or related to a veteran within two degrees of consanguinity (i.e., grandparent, brother, sister, grandchild represent the most distant allowable relationships)
